




#### About us

# MOOT PROPOSITION

#### 6th C.L. Agarwal Memorial National Moot Court Competition, 2022

#### **MOOT PROPOSITION**

- I. Geographical barriers have been broken by developments in Technology. The most glaring impact of this can be seen in the development of Tele-medicine which facilitates the outsourcing of healthcare-related activities to destinations like India which possess a robust medical talent pool which can provide medical services at lower cost.
- II. Anticipating a boom in the healthcare outsourcing activity, Dr. JJ decided to quit his position as Head of Radiology with a leading Pune hospital to set up a company in the teleradiology space. In September 2002, he formed JJ Diagnostics Private Limited along with his wife Stella, and set up a new facility in Pune. In order to safely Beta-test his model, Dr. JJ started discussions with Terry Fox Foundation Cancer Center, California for providing tele-radiology services.
- III. This project was a success for both the parties. The TFF Cancer Foundation benefitted by reduction of costs and time. As a result, TFF Cancer Foundation decided to sign a 5-year contract worth 10 million USD with JJ Diagnostics. Inspired by this success, Discovery Hospital, New Delhi also started a tele-radiology project worth 5 crore with JJ Diagnostics.
- IV. Keeping in mind, the increasing demand on his company, JJ Diagnostics decided to expand their operations and started to seek job-applications for qualified radiologists. The candidates required a minimum qualification of a masters' degree in radiology from any reputed Indian medical college. The advertisement stated that although not a must, a master's degree from a reputed U.S. or U.K. medical college was preferable.
- V. Dr. Manjari was one of the qualified radiologist who decided to seized the opportunity and applied for the post of teleradiologist. In her application, she stated that she had a masters' degree in radiology from the University of Goa and also a further masters' degree from the University of Marlborough in the U.S. As a result of being a qualified candidate, Dr. Manjari was hired by JJ Diagnostics on February 2003. The following were the terms of her contract of employment:

- i. The employee shall work with JJ Diagnostics for a period of at least 5 years, and in case the employee left his/her services within the 5-year period, then all expenses incurred by JJ Diagnostics in training the employee had to be reimbursed by the employee to the company;
- The employee shall maintain strict confidentiality in respect of all information pertaining to customers received during the course of employment with JJ Diagnostic
- iii. The employee shall comply with the provisions of (i) the Health Insurance Portability and Accountability Act of 1996 (HIPAA) and the privacy rules and regulations issued thereunder, and (ii) other data protection and privacylaws as are applicable in India;
- iv. The employment contract can be terminated by either party by giving 3 months' prior written notice; and
- v. In case of termination, the employee cannot be employed with another entity carrying on a competing business, for a period of 2 years from the date of ceasing to be employed with JJ Diagnostics.
- VI. JJ Diagnostcs also provided a 6 weeks training programme with American College of teleradiologists in New Jersey, US. Dr. Manjari and her college, Dr. Johnny were chosen to attend this programme which they completed in March-April 2003.
- VII. Strict confidentiality clauses were included in contracts with TFF Cancer Foundation and with Discovery Hospital, Delhi. In view of this, the obligation of JJ Diagnostics to comply with data protection and privacy laws were passed on to the employees under the employment contracts. In June 2004, Dr. Jacob also received an award from the Indian Medical Council recognizing his pioneering role in the promotion of outsourced healthcare services for India.
- VIII. However, in August 2004, Dr. Jacob received notice from a court in Moonvale, California of a suit filed by the TFF Foundation against JJ Diagnostics seeking damages of US\$ 15 million for breach of its confidentiality obligations by JJ Diagnostics under its contract with the Terry Fox Foundation. The notice claimed that several patients of the Terry Fox Foundation had initiated a suit against its hospital in Moonvale on the ground that their records pertaining to diagnostic information was divulged by the hospital or its agents thereby causing severe harm and damage to the patients, including the death of two patients. An internal enquiry, the Terry Fox Foundation found that all its systems and controls were fully operational and that the data that was leaked related

only to patients whose radiology reports were outsourced to JJ Diagnostics and not to those patients whose reports were prepared internally by the hospital. The Terry Fox Foundation therefore had strong reason to believe that the leak occurred at JJ Diagnostics' end and hence brought about a suit against the later for recovery of damages. A similar action was filed by the Discovery Hospital against JJ Diagnostics in the High Court of Judicature at New Delhi, alleging that JJ Diagnostics had leaked information due to which its patients have sued the hospital.

- IX. Dr. JJ conducted an internal probe headed by a retired judge of Patna High Court. It directly linked the leakage of information to Dr. Manjari, who was until then considered to be a bright and sincere radiologist with an unblemished track record in the company.
- X. Dr. Manjari later confessed that she had passed on patient information to Dr. Ross who was the owner of a pharmaceutical company in US. It was not clear whether Dr. Manjari had received any monetary reward or other benefit for providing this information.
- XI. Dr. Jacob decided not to dismiss Dr. Manjari from employment with the company. Instead, he offered to Dr. Manjari that she could terminate her employment by giving 3 months' notice as required under her employment contract. Therefore, on the very same day, Dr. Manjari submitted her resignation letter terminating her employment effective 3 months from the date of the letter.
- XII. On October 16, 2004, Dr. Manjari addressed a detailed email to Dr. Jacob. In this email she highlighted instances of sexual harassment that she suffered in the company. She mentioned that her team member Dr. Johnny had the habit of rubbing shoulders with her each time they were passing through the office corridors in opposite directions. This, she says, is a deliberate act on the part of Mr. Johnny as it has occurred on various occasions over a long period of time. Further she states in her email that during a few overseas trips, in spite of repeatedly requesting him not to do so, Dr. Johnny would ensure that his seat on the airplane was next to that of Dr. Manjari, and that he would constantly attempt to engage in a conversation with her, without enabling her to take any rest during a long and tiresome journey. Further, his conversations were often very rude and impolite. In fact, on one occasion, he told Dr. Manjari with reference to a lady sitting across the aisle, that "the female over there is very cute". Dr. Manjari strongly protested against this and told Dr. Johnny that this was denigrating and humiliating of women. In her letter, Dr. Manjari wrote to Dr. Jacob that this amounted to sexual harassment suffered by her and that she needs to be appropriately redressed.
- XIII. As a response to this, Dr. Jacob replied that upon conducting a background check, it was found that Dr. Manjari had not received a degree from the University of

Marlborough as she had claimed in her application for employment. Therefore, apart from divulging confidential information regarding patients, she had also committed fraud on JJ Diagnostics by lying about her educational qualifications. As regards the sexual harassment allegations, an internal inquiry committee headed by Dr. Jacob heard Dr. Manjari in detail and thereafter convened a meeting on December 10, 2004 to hear Dr. Johnny.

- XIV. Criminal allegations regarding data theft under section 43 of IT Act have beenlevelled against Dr. Manjari by JJ Diagnostics.
- XV. Further criminal allegations of resume fraud have been levelled by JJ Diagnostics against Dr. Manjari.

# RULES AND REGULATION

#### **RULES & REGULATIONS**

#### 1. Team composition and eligibility criteria

- i. Each team shall comprise of three (3) members out of which two (2) will be speakers and one (1) researcher. An observer is allowed to be brought to the competition with a condition that he/she shall not intervene in any proceedings.
- ii. The competition is open for bonafide students pursuing 5 Years and 3 Years Law programs in India.
- iii. Each Law College shall be eligible to send one team. Each team shall be provided with the TEAM CODE. Team should not disclose the identity of their institution in course of proceedings in the court rooms; such disclosure shall invite penalties including disqualification.

#### 2. Registration

- i. The teams are requested to send an e-copy of the Registration Form to <a href="mcc@rafflesuniversity.edu.in">mcc@rafflesuniversity.edu.in</a> on or before 08-08-2022.
- ii. A registration fee of Rs. 4500/- (Rupees Four Thousand and Five Hundred Only) is to be paid by way of Online Money Transfer / UPI / Paytm / Google in favour of Raffles University. The charges for observer will be Rs. 800 (Eight Hundred only) per day.
- iii. Payment to be done by online mode. Details are as follows-

- iv. No change in the names of the participants shall be permitted after the receipt of the Registration Form, except at the sole discretion of the Organizers.
- v. Teams should clearly mention the participants name including year / semester of study.
- vi. The moot court will be conducted on Date: 26<sup>th</sup> Aug 28<sup>th</sup> Aug, 2022. The inauguration function will commence sharp at 10:15 AM on 26-08-2022 followed by draw of lots and preliminary rounds.

#### 3. Dress Code

Inside the court room the participant shall strictly follow the below mentioned dress code.

- i. Females: White Salvar kurta & Dupatta or white shirt and black Trousers along with black coat and tie.
- ii. Males: White shirt, black trousers, black tie along with black coat and black shoes.

#### 4. Competition Rounds

There shall be two preliminary rounds, octa-finals, quarter finals, semifinals and a final round spreading over a period of 3 days.

#### I. Preliminary Rounds

- i. In preliminary rounds each team shall argue from both the sides (Plaintiff and Defendant).
- ii. The team shall be credited with a win in a preliminary round if their round total is more than opposing team.
- iii. The marks of the EACH preliminary round shall be the cumulative total of the marks of both the speakers and the marks of the memorial of the side in which they are appearing.
- iv. The total marks of the preliminary rounds shall be the sum total of the marks of both the prelim rounds.
- v. No team shall face each other more than once in the preliminary rounds.
- vi. TOP SIXTEEN (16) teams shall move to the Octa finals on the basis of the marks of the preliminary rounds.
- vii. The following criteria shall be observed in deciding teams which are to move forward to octa-finals.
  - a) The teams that have Two wins in preliminary rounds shall proceed to the octa-finals.
  - b) In case less than 16 teams are able to score two wins then teams that have 1:1win loss ratio shall advance based on their aggregate score in the Preliminary Rounds.
  - c) Teams that have Two wins shall be given preference over those which have 1 win and 1 loss.
- viii. In case of a tie between two or more teams, the aggregate total of the score of oral submissions of the speakers shall be taken into consideration.

#### II. Octa-finals

- i. Happening of Octa-finals is subject to change in case participating teams' number is less than 30.
- ii. It shall be a knock-out round and the winner of each round shall move forward to the quarter finals.
- iii. The criteria of marking in this round are aggregate total of the marks of both the speakers and the marks of memorial of the side in which they are appearing.
- iv. In case of tie between teams, in octa-finals, the aggregate total of the marks of memorials (Plaintiff and Defendant) of the teams shall be counted. Team with highest marks moves ahead.

#### **III.** Quarter Finals

- i. Eight (8) teams shall compete in quarter final. Criteria for qualifying to quarter finals have been mentioned in previous clauses.
- ii. It shall be a knock out round. The winner of each round shall move to the semi-final. Four (4) teams shall move to semi-finals.
- iii. The criteria of marking in this round are aggregate total of the marks of both the speakers and the marks of memorial of the side in which they are appearing.
- iv. In case of tie between teams, in quarter finals, the aggregate total of the marks of memorials (Plaintiff and Defendant) of the teams shall be counted. Team with highest marks moves ahead.

#### IV. Semi Finals / Final

- i. Four (4) teams shall compete in semifinals. The criteria of qualifying in semifinals have been mentioned in pervious clauses.
- ii. It shall be a knock out round. The winner of each round shall move to the final.
- iii. The criteria of marking in this round are aggregate total of the marks of both the speaker sand marks of the memorial of the side in which they are appearing.
- iv. In case of tie between team, in semifinals, the aggregate total of the marks of memorials (Plaintiff and Defendant) of the teams shall be counted. Team with highest marks moves ahead.
- v. There shall be one (I) FINAL Round.
- vi. The marking criteria in Final Round is same as that of semifinal [clause IV, (iii)].

Note: The teams shall be allotted their respective sides through draw of lots.

#### 5. Memorial

i. All teams must submit Memorials/Written Submissions for both sides.

(Plaintiff-Defendant).

- ii. Participants must at least frame 3 issues.
- iii. Memorials must contain the following:
  - a) Cover page / Cause title
  - b) Index
  - c) Index of Authorities
  - d) Statement of Jurisdiction
  - e) Synopsis of Facts
  - f) Summary of Arguments
  - g) Arguments / Pleadings
  - h) Conclusion / Prayer.
- iv. The Arguments shall not exceed thirty (30) pages.
- v. The Memorial shall be typed on A4 size page in Font type: Times New Roman, Font size: 12, 1.5-line spacing & 1-inch margin on each side. For citation Blue Book 20<sup>th</sup> edition must be followed.
- vi. The Cover Page of the Memorial must follow the following color scheme, Blue for the Plaintiff Cover Page and Red for the Defendant Cover Page.
- vii. The Memorial must be 'spiral binding' ONLY. No services regarding spiral binding will be provided by theuniversity.
- viii. If any team needs to get photocopies done in the university, it would be charged.
- ix. The Memorial must not contain any Annexure / Photographs / Sketches / Exhibits /Affidavits etc.
- x. Memorials that do not comply with the above-mentioned specifications will befined.
- xi. Soft copy for each side (Plaintiff and Defendant) must reach the organizers latest by 17-08-2022 to Moot Court Committee <a href="mac@rafflesuniversity.edu.in">mcc@rafflesuniversity.edu.in</a>, and hard copy of the same and compendium shall reach the School of Law, Raffles University, Japanese Zone, NH-8, Neemrana-301705 District- Alwar, Rajasthan, India latest by 20-08-2022. Total of 5 hard copies have to be submitted to the organizers out of which 2 of each side are to be delivered by 20-08-2022.
- xii. Identification of any type shall attract severe penalty.

#### **Marking Criteria for Memorials**

- i. Memorial from each side shall carry total of hundred (100) marks.
- ii. The following shall be the criteria for marking the memorials.

iii. A penalty of two (2) marks for each side of memorial shall be entailed on each day default in submissions of memorials.

#### 6. ORAL SUBMISSIONS

- i. Each team shall comprise of two (2) speakers, as has been specified earlier.
- ii. Each team will have a maximum of thirty (30) minutes to present their Oral Submissions in Preliminary Rounds. No speaker will be permitted to address the Court for more than seventeen (17) minutes. This includes the time the speaker addresses the Court during the rebuttal. The maximum time for rebuttal is five (5) minutes.
- iii. Passing of chits will only be allowed during Preliminary rounds. The maximum time allotted in octa and quarter finals is forty (40) minutes for oral submission and no speaker will be permitted to address the Court for more than twenty-two (22) minutes inclusive of five (5) minutes for rebuttal.
- iv. The semifinal rounds will be of Forty- Five (45) minutes and final round will be of fifty (50) minutes for each team. No speaker shall be allowed to address the court for more than twenty-five (25) minutes and twenty- eight (28) respectively.
- v. At the commencement of each session of Oral Submissions each team shall notify the Court Officer as to the division of time between the 2 speakers.
- vi. If any speaker continues to speak after the completion of his / her time, he/she shall entail penalty which shall be upon the discretion of the judges.
- vii. Speakers shall not be allowed to pass annexure to the judges; instead, the teams may make a compendium of annexure that shall be given to the judges before the start of proceedings
- viii. During the course of the Oral Submissions no speaker shall reveal his / her identity nor the identity of their University / College by any means whatsoever.

#### **Marking Criteria for the Arguments:**

- i. Each Speaker will be marked on a total of 100 marks by each Bench Judge.
- ii. The following will be the Marking Criteria and the Marks allocated to each Speaker by each Judge in the Round:

- ii. If there is any dispute in regard to the interpretations of the rules or with respect to any matter related to the competition which is not contemplated in the rules, the decision of the Organizers shall be binding and final.
